DURING THEIR TIME AT PATHWAYS STUDENTS HAVE OPPORTUNITIES TO GROW IN THEIR CHRISTIAN FAITH, PARTICIPATE IN CONTINUED EDUCATION, VOLUNTEER IN THE COMMUNITY, AND HAVE AN ACTIVE LIFESTYLE. IN 2016, 50 ADULTS AND THEIR FAMILIES WERE SERVED. PATHWAYS IS OPEN YEAR-ROUND AND CLOSED FOR A TOTAL OF FOUR WEEKS FOR STAFF TRAINING AND HOLIDAYS.
